

# NM Jets Cheer and Dance Programme

## PERSONAL DATA CONSENT FORM – PARTICIPANTS UNDER 12

During your child's time with us we will gather information about them which we will use for various purposes. A Privacy Notice has been provided to you in relation to the use of this information. That Privacy Notice is also available on the NM Jets website ([nmjets.org.uk](http://nmjets.org.uk)).

There are some things that we cannot do unless you tell us that we can. We have set these out in the table below. Please read this form very carefully and tick the appropriate options. This will let us know which of these things you are happy for us to do, and which you are not.

If you are not happy for us to do any of the things in the table below then this will not affect your daughter's place on the NM Jets Cheer and Dance Programme (hereafter referred to as "the programme") although it may affect her ability to compete (see below). You are completely free to refuse to provide your consent to any of these things. You do not have to provide reasons for refusing your consent, but we are happy for you to give us additional information if you choose to so that we understand any concerns that you have and can take appropriate steps where necessary.

### Photographs and videos

Some of the information in the table below includes photographs and videos of your child. We assure you that we take very seriously the issue of potential misuse of photographs and videos of our participants, and have the following measures in place:

- We save all files on secure networks which are password-protected

The programme may provide photographs and videos to the media, or the programme may be visited by the media who will take videos and photographs. When these have been submitted to or taken by the media the programme has no control over these.

We ask that you please carefully consider this consent form, complete it and return it to us. We will not be able to do any of the following without you having returned this form confirming that you consent to us doing so. Therefore, if you want us to be able to use this information for these purposes then you must indicate this to us.

You are not required to consent to the use of information in the table below and if you do not consent then this will not impact on your daughter being able to participate on the programme; however, please be aware that it is standard practice for us to commission the recording of videos and photographs of participants during competitions and, if you do not consent then this may have an impact in terms of your daughter's ability to enter competitions with us.

**Celebrating your child’s achievements, promoting the programme and reporting on events**

We want to be able to promote the NM Jets Cheer and Dance Programme (hereafter referred to as “the programme”) to attract new participants and funding sources and to display the quality of performances. This may also involve the reporting of events involving the programme such as competition wins. As part of this we want to be able to use photographs and videos of your child in promotional material and media reports.
