Please note the following important information before signing this form. The trips and activities covered by this consent include:

- all visits (including residential trips) which take place during the holidays or at a weekend
- off-site sporting fixtures outside school hours
- training sessions (both within and outside the normal school day)

The programme will provide you with information about each trip or activity before it takes place; usually this will take the form of a letter. You can also find out about forthcoming trips by checking our website (nmjets.org.uk).

In order that my child may receive the necessary medical treatment in the event that s/he might sustain injury or become ill while participating in these activities, I authorise the cheerleading coach or other supervising adult to obtain medical treatment for such injury or illness during the activity and I hold NM Jets Limited and Norbury Manor, along with their supervisors, representatives and associates, harmless in the exercise of this authority.

I acknowledge the inherent risks involved when taking part in cheerleading and dance. I allow my child to participate in NM Jets events and training and agree to be legally bound to agree to release NM Jets Limited and Norbury Manor, along with their supervisors, representatives and associates, from all liability and responsibility for any claims relating to personal illness, injury, sickness, loss of money and property or damages that my child may sustain during participation in this activity, including travelling to and from an event. However, I also understand that nothing in this agreement shall have the effect of excluding or limiting any liability for death or personal injury caused by any negligent act or omission on the part of any member of staff of NM Jets Limited and, further, that nothing in this liability release shall limit or exclude any of the liabilities of NM Jets Limited in any way that is not permitted under applicable law.

I have completed the NM Jets Healthcare Form, do not know of any problems that may adversely affect my child's health when taking part in physical exercise and cheerleading and confirm that my child has not been advised by a doctor to avoid physical exercise. I am aware that cheer and dance can be dangerous activities. I have completed and returned the forms given to me by the programme and have impressed upon my child the need to follow instructions and rules carefully at all times. I am aware of how s/he intends to get home after training and understand that reliable attendance every week is crucial to the squad's progress.
